# How to Complete State Application on Registry

Now that you have been seen by a qualified physician & approved we are going to help finish up your registration.

## How to Login to the registry:

Website: <https://mmuregistry.flhealth.gov/>

Username: Your Email

Click "Your Card" in the upper left-hand corner

### Once in "Your Card" you will complete the follow steps. (IN THIS ORDER)

1. Review all the information is correct that the Physician entered.
2. You will see a picture of yourself (if there is NO picture you must upload one that has a white background and be sure not to have anything on your head or covering your face).
3. Upload proof of residency *see Acceptable proof of residency BELOW*
4. Next you type your name in the signature section and click "submit"
5. After clicking "submit" a box will appear under "Payment Record" clicking this will allow you to submit your \$77.75 payment (\$75 plus \$2.75 convenience fee) electronically with a card/bank account **OR** you can mail in a check (but mailing a check can delay the process) **\*\*This \$75 is paid YEARLY to the state (follow the instructions listed on the back of your card) and is separate from any Doctor Fees\*\***

**\*\*You are now done registering\*\***

**\*\*The next step is to wait for the states answer\*\***

Generally, within **10-12 BUSINESS DAYS** you will receive and email stating you were approved or denied.

- If approved, you can print that email and it will act as your **TEMPORARY** card until your actual card arrives in the mail. (could be a few months before the card comes in the **mail**)
- If denied, the email will explain why. At this point you can fix the issue stated in the email and give the Office of Medical Marijuana Use a call to let them know the issue was fixed. (Calling right away will usually speed the review process up)

### Acceptable Proof Of Residency

- **Florida Resident:** A VALID Florida ID or Driver's License (Address must match registry)
- **Seasonal Resident:** 2 approved documents per the statute. Let us know if you are seasonal and we will help you get the information
- **Minors:** Birth Certificate or current record of registration from Florida k-12 school & a valid Florida ID of a parent or legal guardian.

# USEFUL HOW TOs

**Both Scenarios you will follow steps 1 through 4 then follow the steps under the correct scenario you are needing**

1. Go to the registry at: <https://mmuregistry.flhealth.gov/>
2. Click Log in
3. Type your Username: The Email you provided to the doctor
4. Type your Password: whatever you made it as If you don't remember your password, click "Forgot Password?" at the bottom of the login box. Type your email in and an email will be sent to you with a temporary password.

## **How to Release Yourself from Your Current Physician**

Once you have logged in with either the password or temporary password you will: • Click on "Your Profile" • Scroll down and click "manage profile details" • At the bottom you will click "leave current physician" • The click Submit.

## **How to Renew Your Card**

**Card is renewed once a year**

Once you have logged in with either the password or temporary password you will: • Click on "Your Card" • Scroll down to just below your demographics • You will click "Begin Renewal Process" Here you will: • Update any info needing to be updated • Upload a new copy of your ID (IF NEEDED) • Sign the bottom • Pay the \$75 dollars (plus \$2.75 convenience fee)

# Concealed Weapons Firearms & Medical Marijuana

This information is based off of the **FLORIDA STATUTES** (updated in 2018)

**Chapter 790, WEAPONS AND FIREARMS** is where **790.06** License to Carry Concealed Weapon or Firearm can be found. The whole chapter is about 6 pages long and at **NO** point addresses **MEDICAL** Marijuana. Also, as seen below on question 14 of the Florida's Concealed application there is **NO** talk about the use of **MEDICAL** marijuana **ONLY** commitment for ABUSING substances.

## 14. During the three years preceding the date of this application, have you been:

a. Committed for the abuse of controlled substances, or been found guilty or convicted of a crime under the provisions of Chapter 893, Florida Statutes, or similar laws of any other state, or had multiple arrests for such offenses within the past five years with the most recent arrest occurring within the past year?

b. Committed for the abuse of alcoholic beverages or other substances under the provisions of Chapter 397, or under the provisions of former Chapter 396, Florida Statutes, or convicted under Sec on 790.151, Florida Statutes, or been deemed a habitual offender under the provisions of Sec on 856.011(3), Florida Statutes, or similar laws of any other state?

c. Convicted two or more times in the previous 3 years, under Sec on 316.193 Florida Statutes, or similar laws of any other state for driving under the influence of alcohol or a controlled substance?

If you answered YES to any of questions 14a, 14b, or 14c, you are not eligible for licensure.

### \*\*\*REMEMBER\*\*\*

Having a **CONCEALED** and **PURCHASING** a weapon is **DIFFERENT!**

- ✓ A concealed is given by THE STATE
- ✓ A firearm sale is approved by THE FEDERAL GOVERNMENT

When trying to **PURCHASE** a firearm from a dealer, they are required to run a **FEDERAL** background check. On the federal background check question 11E has changed. If 11E is answered **YES**, then it is **LIKELY** that person will be denied and not be able to purchase that weapon at that time.

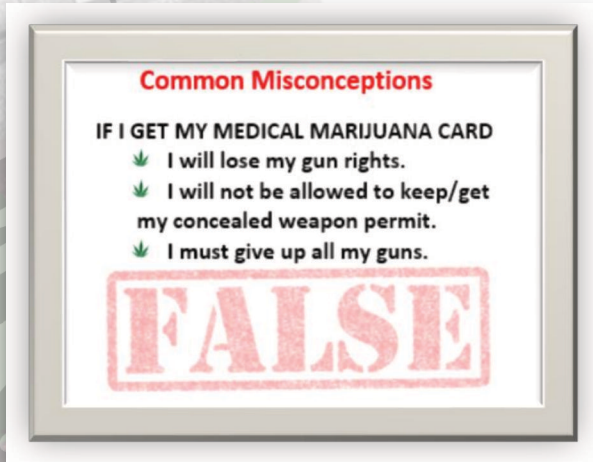
21. Answer the following questions by checking or marking "yes" or "no" in the boxes to the right of the questions.

e. Are you an unlawful user of, or addicted to, marijuana or any depressant, stimulant, narcotic drug, or any other controlled substance?

**Warning: The use or possession of marijuana remains unlawful under Federal law regardless of whether it has been legalized or decriminalized for medicinal or recreational purposes in the state where you reside**



After speaking **DIRECTLY** to **The Department of AGRICULTURE**, the understanding was at no point in time will a person be denied their concealed or renewal solely based on the person having a medical marijuana card. It was said even though it is extremely unlikely, if at any point Florida changes the statute to state a person cannot possess both cards then they will be notified and given a grace period to decide which one they would like to keep.



**\*\*Bottom Line is Medical Marijuana will NOT affect the Concealed Weapons Permit However depending on how YOU feel 11e should be answered , it could hinder the ability to purchase a firearm\*\***

# Basic Information

**THC: Symptom and/or Pain Relief. Gives That 'High' Feeling.**

***Beginners Dose: 3-5mg of oral THC or 2-3 seconds***

**Indica** - nighttime, insomnia, anxiety

**Sativa** - daytime, depression, fatigue

***\*Caution: Sativa may induce anxiety in patients who are prone to it\****

**Hybrid** - balance of indica and sativa

***\*Indica Dominant strains are preferred for anxiety patients\****

**CBD: Long Term Healing (Minimal THC = No High Feeling)**

Anti-inflammatory, Pain, Anxiety, GI Upset, Migraines, Increased Bone Density, Prostate Health, Cancer, and Peripheral Neuropathy

**RSO: Rick Simpson Oil *\*This Product is very Strong\* Start SLOW!!***

a full extract cannabis oil meant to be taken orally or applied topically

Seizures, Loss of appetite, Glaucoma, Migraines, Chronic pain, Inflammation, Multiple Sclerosis, and most importantly CANCER.

## What We Have Seen Work as a Baseline

- ▶ Vape CBD 4 -5 inhalations at minimum 3 times a day.  
*\* CBD is 8x more effective with vape and takes about 1 to 2 weeks to take full effect. \**
- ▶ Hybrid or Sativa if daytime symptoms are severe
- ▶ Indica at night before bed or as needed for anxiety

***\*Oral THC takes 1-2 hours to work and lasts 6-8 hours (Beginner dose: 3-5mg)***

***\*Inhaled THC takes 10-15 minutes to work and lasts 3-4 hours (Beginner dose: 2-3 seconds of inhalation) \****



# Cannabinoids

There are currently 100s of known cannabinoids and terpenes found in the cannabis plant. THC and CBD are the two main cannabinoids that are the most abundant and researched. What's the difference?

## THC

THC is the cannabinoid that is typically attributed to the plant's psychoactive effects.

## CBD

CBD is the cannabinoid in cannabis that produces many effects similar to THC, without the psychoactive effects.

Selecting certain cannabis products will lead to different types of effects. For example, selecting a CBD-dominate cannabis product may support the reduction of inflammation, while a THC -dominate product may control pain, nausea, and vomiting.

## High CBD

*Euphoric Effects associated with THC are milder in high CBD varieties*

## High THC

*High THC strains are believed to be responsible for most of marijuana's sleep inducing effects.*

Anti-Anxiety   Anti-Inflammatory   Pain Relief   Anti-Nausea  
Anti-Spasm   Anti-Tremor   Anti-Convulsant   Nighttime Use

## Balanced

*Combining benefits from both strains.*

A balanced cannabis strain is characterized as having a THC to CBD ratio that is close to 1:1. A balanced strain produces effects associated with both THC and CBD



## INDICA STRAINS

Indica strains have a relaxing, sedative effect, often used to:

- Reduce Stress
- Relieve Pain
- Limit Anxiety

Indica strains are a bushy plant that can grow between 3 and 6 feet tall and are suitable for growing indoors.

Indica strains are sedatives/ relaxants and are effective for treating the symptoms of medical conditions such as anxiety, chronic pain, insomnia, muscle spasms and tremors.

## SATIVA STRAINS

Sativa strains have an uplifting effect.

- Improved Mood
- Stimulant Effect
- Alertness and Optimism

Sativa strains grown tall and thin- the plant can grow up to 20 feet in an outside garden.

Sativa strains are more of a stimulant, and are effective in appetite stimulation, relieving depressions, migraine pain, chronic pain, and nausea.

## HYBRID STRAINS

Hybrid strains offer a mix of effects, combining the traits they inherited from their parent strains. Hybrids are known for:

- Limit Anxiety Inducing Effect of Sativa Strains.
- Limit Sedating Effects of Indica Strains.
- Chronic Pain Relief.

Of the roughly 779 strains, over half of them are hybrids.

Hybrids that carry effects from both strains. By combining the strains you can reduce some of the unwanted symptoms of either strains while maintaining the benefits of each parent strain.



# TERPENES

Terpenes are the organic compounds responsible for creating the unique aroma of each individual cannabis plant. They do more than determine the scent finger print, they also provide therapeutic benefits like their cannabinoid partners, THC and CBD. When terpenes work together with cannabinoids, the therapeutic potentials increase dramatically. Terpenes can also modify how much of each cannabinoid is absorbed. This means the presence of certain terpenes can increase or decrease the amount of the psychoactive cannabinoid THC is absorbed, effectively controlling the potency.

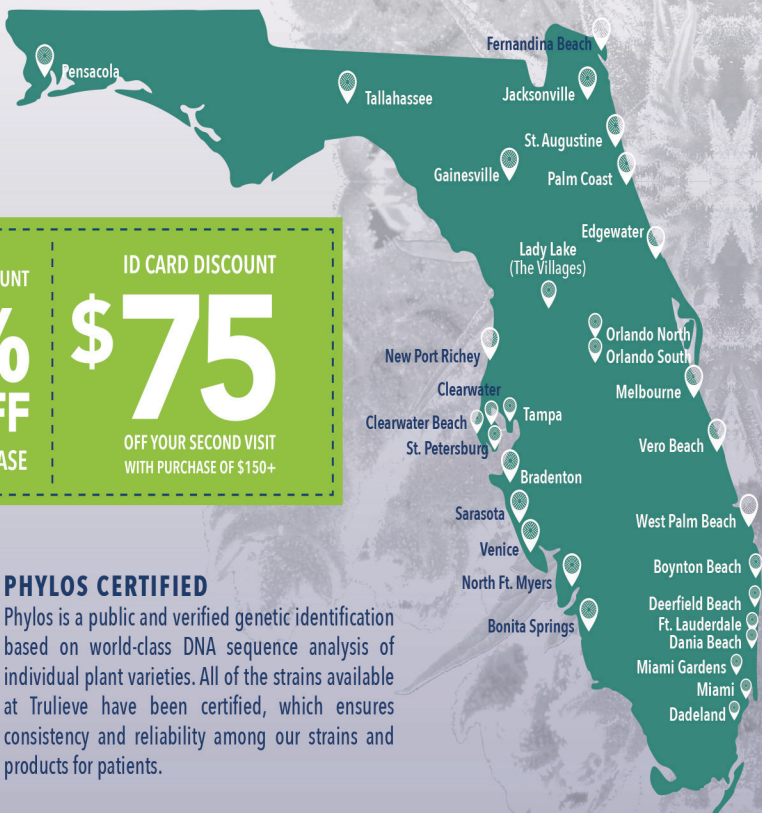

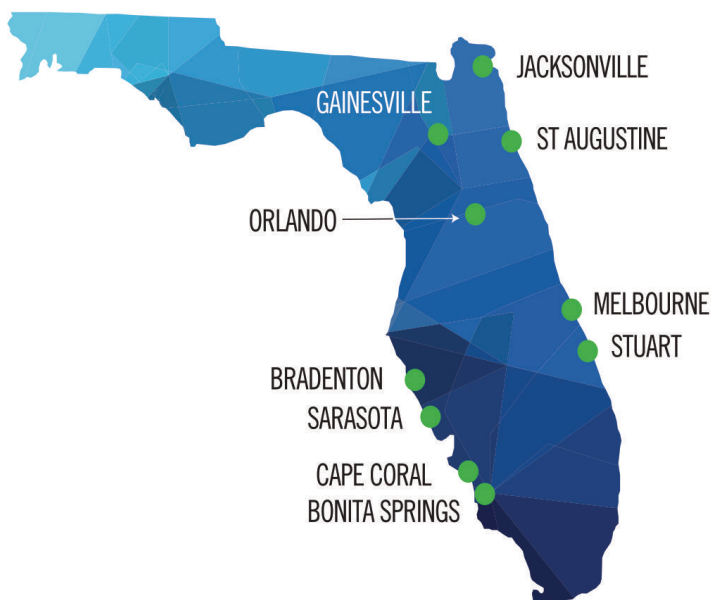

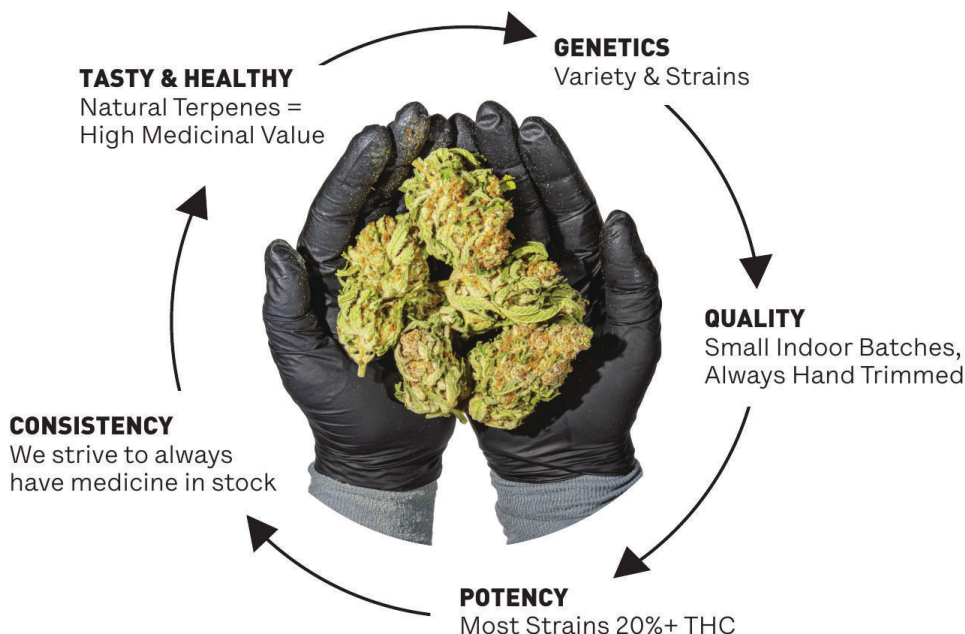
